GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Wildwood Water Service is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. In September 2024, we failed to monitor for Manganese. Adverse health effects, if any, are not known. Monitoring procedures have been corrected to avoid further violations.

ADDITIONAL HEALTH INFORMATION

Infants and young children are typically more vulnerable to lead in drinking water that the general population. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing, If you are concerned about elevated lead levels in your home's water, you may wish to have your water tested and flush your tap for 30 seconds to 2 minutes before using tap water. SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the North Raccoon sand and gravel of the alluvial aquifer. The Alluvial aquifer was determined to be highly susceptible to contamination because the characteristics of the aquifer and overlying materials provide little protection from contamination at the land surface. The Alluvial well will be highly susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
